1. PURPOSE

Tomago Aluminium (TAC) holds an Environment Protection Licence with the NSW Environment Protection Authority (EPA). As per the *Protection of the Environment Operations Act 1997* (the POEO Act), the holder of an Environment Protection Licence must prepare, keep, test and implement a pollution incident response management plan (PIRMP) that complies with Part 5.7A of the POEO Act in relation to the activity to which the licence relates.

If a pollution incident occurs in the course of an activity so that material harm to the environment (within the meaning of section 147 of the POEO Act) is caused or threatened, the person carrying out the activity must **immediately** implement this plan in relation to the activity required by Part 5.7A of the POEO Act.

A copy of this plan must be kept at the premises, and be made available on request by an authorised EPA officer and to any person who is responsible for implementing this plan.

Parts of the plan must also be available either on the website (www.tomago.com.au/health-safety/emergency-response).

As such this program defines Tomago Aluminium's approach to emergency preparedness and response to HSE incidents at the Wallaroo Landfill Facility. The objective of the program is to ensure:

- Emergency situations that may occur on the Wallaroo Landfill Facility are managed to reduce the severity of incident and impact on site personnel and neighbouring premises.
- Ensure comprehensive and timely communication to the staff at TAC, relevant authorities and people outside the facility that may be impacted.
- Ensure that key personnel responsible for the implementation and maintenance of the plan are identified and staff are trained and experienced to deal with emergency situations.
- Compliance with statutory requirements such as *Protection of the Environment Legislation Amendment Act 2011*

5. BACKGROUND TO WALLAROO FACILITY

Wallaroo landfill is a Class 2 Solid Waste Landfill according to the classification assigned by the NSW Environmental Authorities. The site currently operates in accordance with an Environment Protection Authority licence issued under the Protection of the Environment Operations Act (Licence # 6048).

6. WASTE DESCRIPTION

Two smelter production waste streams containing fluorides are the basic source of materials historically disposed of at Wallaroo. These wastes need to be properly managed to avoid uncontrolled leaching of fluoride into the groundwater. All wastes disposed at Wallaroo are kept in capped Landfill cells. The two production waste streams are:

- a fine residue known as "dross" which results from the reaction of air with molten aluminium.
- A carbon dust that results from the shot blast cleaning of anodes

Due to the public debate surrounding development of the landfill in the mid 1980's, there is a misconception by some that solid wastes containing cyanide components i.e. spent pollinings, have been landfilled at the site. Spent pollinings have never been landfilled at Wallaroo.

Following the development of alternative reuse solutions for the waste materials, Tomago Aluminium ceased disposing of approved smelter wastes at the site in 1999. All cells are capped and the site is regularly maintained

Presently 50,000 tonnes of 'approved smelter waste' is disposed at the facility. This waste was approved by the Environment Protection Authority prior to disposal and certified to contain not more than 150 mg/L leachable fluoride.

The landfill cells are designed to protect the local environment, primarily the groundwater table, from potential uncontrolled leaching of fluorides from the waste materials.

7. HEALTH AND SAFETY RISKS

There is no inventory of hazardous materials or chemicals stored on the site. The landfilled materials do not pose any health and safety risks to personnel visiting or maintaining the Wallaroo site and are assessed to pose no risks under the potential emergency scenarios identified in section 9.

8. MONITORING AND ONGOING MANAGEMENT

Groundwater and surface water on the site and the environs are monitored on a three monthly basis. This monitoring program has been conducted since the site commenced operation in 1987 and to date no elevated levels of fluoride have been detected. Monitoring data is regularly reported to a number of statutory bodies.

Access to the site is closely managed to prevent activities that have the potential to damage the landfill cells and to prevent activities that can cause erosion of the site.

9. IDENTIFICATION OF POTENTIAL EMERGENCY SITUATIONS AND PREVENTATIVE CONTROLS

Due to the scale and operational status of the Wallaroo facility potential emergency scenarios are identified to include:

Bushfire


Fire breaks are established around the perimeter fencing and vegetation within the compound are maintained to reduce the bush fire risk. No environmental or health risks are expected if a fire occurred inside the compound. Quarterly visits to the site allow the condition of the fire breaks and vegetation within the compound to be assessed.

Waste storage cell leakage resulting in groundwater contamination.

Groundwater at the Wallaroo landfill facility is sampled and analysed on a three monthly basis. This regular testing will ensure early detection of any waste cell leakage. The following approach would be followed in the event that contamination of groundwater was detected.



10. COMMUNICATIONS OF EMERGENCY SITUATIONS

The Security gatehouse at the Tomago Aluminium Smelter is the Site's Communication and Fire Control Centre. In the event of an emergency, injury or pollution incident the Environment Superintendent will be notified and is responsible for notification of authorities in accordance with TAC procedure:
